Since the submission of our Annual Report for 2003/04, we have completed the following scheduled activities [output number]:

- a) Darwin Fellow Gorky received 2 months of training, completing a total of 32.5 months for the project [5].

The PI failed to notice that the stated end date of the project had not been officially changed from 30 June 2004 in spite of several updated schedules being submitted to Darwin in Annual and Half-year reports indicating that the final outputs would not be completed until 2005. (Although the PI accepts full responsibility for this oversight, it should be noted that the discrepancy wasn't noticed by either the Darwin staff or ECTF reviewers.) To complete the project outputs, the PI requested in July 2004 that the end date be extended until 31 March 2005 so that the remaining £ 14,000 might be used to complete the project within the same fiscal year. In spite of multiple enquiries over the past five months, we have not yet been informed whether this request has been approved or not. No further progress is possible until we know we can use the allocated funds.
