Minutes of the National Liaison Committee meeting held on 10th March 2005, at the Centre for Biodiversity Seminar Room of the National Museums of Kenya.

The meeting was called to order at 10:50 a.m. A round of introductions was done. The Chair requested members to propose items for the agenda and confirm it. Minutes of the NLC meeting of 4th March 2004 were read.

Min 05/49. Matters arising -

- Min 04/42. Matters arising Members were informed that Nature Kenya (NK) is in process of establishing a Media Working Group with the Nation Newspaper. The Nation Newspaper is one of the private sectors that are being targeted to sit in NLC meetings.
- Min 04/43. Institutional reporting NK sent their contribution to be included in the promotional brochures that was developed by the KTB and they had linked up with partners in Germany (Birdlife Germany) to promote Kenya IBAs specifically Arabuko-Sokoke.
 - ELCI have created a website that is www.elci.org and one can get more information on Forest Certification by opening this website. NLC Members were once again reminded to contribute to Eco-forum Magazine because they have never made any contribution.
- Min 04/44. Members were informed that a Task Force that was formed to look at all sites important for biodiversity met on 22nd March 2004 where were able to look at the map of the Northern By-pass road. The discussion to carry out Environmental Impact Assessment (EIA) is still in process. After the EIA has been carried, members of the public to be informed on the outcomes. The EIA is being funded by JICA. The NGOs were requested to be bringing up their issues to the government early enough before a project is set up on the site that is not environmentally friendly.
- Min 04/46. NLC is will to assist NEMA in national reporting to CBD, therefore NLC members requested for an official letter from NEMA through the Director General that authorise the NLC to perform the above duty.
- The new members who were their first time to sit in the NLC meeting were given an overview on how IBA NLC came about and who are the members.

Min 05/50 Institutional Reporting

WCK

Isabella Mbandi reported

- Members were informed that magazine is in circulation and the members were still welcome to contribute to it.
- WCK support working with communities as is the case with Lake Victoria Sunset Birders in Kisumu to promote school environmental education.
- NIC members were welcomed to the college that is situated at the WCK headquarter (Langata) to advice students and give lectures on environmental issues and also to the teach them more about birds and how to ring them
- It was reported that Mobile Education Unit do disseminates environmental education to pupils through the country.

Comments/issues

 Mt. Kenya Eco-resource Centre a Nature Kenya project will be in operation and WCK were asked for partnership in order to make the centre more active.

CDTF-BCP

J. Ruhiu reported

- This institution supports conservation initiatives in Kenya.
- Its 5 year project programme is ending on September 05 but some projects are extending up to Jan 2006
- BCP have remitted all the money to the beneficiaries for the projects which are ending 2005
- The second phase will be a completely different programme shift from biodiversity to general environmental issues like link environment and poverty. This is a strategic plans for NEMA and is expected to start sometimes next year 2006
- BCP have supported Site Support Groups through Nature Kenya in Kikuyu Escarpment, Mt. Kenya etc.
- BCP have also support ed some Forest Department programmes

Comments/issues

- NLC members will look for a way they can assist the local communities through BCP funding.
- Members were informed there would be a paper document to be discuss in Brussels (EU) and the stakeholders will be invited to give their views later.
- On the new programme yet to come, Kenya Government and European Union have identified a consultant to look on the issues that have not yet been address by BCP on the previous project funding and the focus will be on Poverty and Environment

Forest Department

Maurice Wanyiri reported to follow up on report

- FD has restructured its programmes and staff to enhance its efficiency, effectiveness and better management in the forest estates (IBAs inclusive).
- Members were informed that there were eviction of squatters in Mau complex forest and other forests that had been inverted by squatters were also targeted
- It was reported that the Forest bill 2005 has been amendment and it is to be tabled in parliament once it is open in March 05. There is a high chance to be passed because of good political will

Comments/issues

- NLC Members request FD to update them on the progress between and the World Bank support.
- FD informed members that there was meeting that was going on at Nyeri at the same date the NLC was having theirs, that meeting was basically to discuss the issues affecting Mt. Kenya ecosystems.
- FD is now cooperative to work with other stakeholders unlike before
- On PFM Guidelines members were informed that pilot exercises are still going on in Arabuko-Sokoke, Mukongodo in Laikipia districts and there is a plan for other districts (written report to be circulated to members).
- FD have not utilized the funds that was given by BCP to carry out some conservation activities in the forest
- NLC members gave FD go a head to carry on with the conservation activities.
- At first the was a problem at Kakamega forest where one of the SSGs i.e. KEEP was not permitted by FD to put up a tree house that had been supported by GEF small grants but later they issued a letter authorising them to go a head with the project. This is a positive experience with partnership.
- Therefore members requested FD to be flexible in working with other stakeholders

NMK

Ronald Mulwa reported

- NLC members were informed that NMK have an office of Centre for Biodiversity were all
 the records of animal species can be access and is also an office of sharing information on
 Biodiversity.
- NMK is managing a database on research papers
- Involves in collecting information Natural Sciences
- Currently, NMK are embarking on site based programmes i.e. working with other stakeholders such as KWS among other stakeholders. For example there are working with KFWG in Biodiversity survey in Ngong forest.
- NMK inconjugation with Makerere University are carrying out baseline survey in Mt. Elgon funded by IUCN

Comments/issues

- NMK information are available in form of Electronic and soft copies and each has a title and the subject.
- NMK cannot put all the information they have in the web site but they can only identify some relevant fields to put in the website.
- NK are working closely with NMK, the 94 years working relationship has translate the work on research (data from NMK) to action.
- Birders can now access Internet on the information concerning birds at NK office and there
 are plans to connect it to NMK, this is a support by the Kenya BirdFinder project and NMK
 is the host.
- NMK scientists contributes to Eastern Arc database which is being supported by IUCN

UNDP

Charles Nyandiga reported to get matrix after Esther

- UNDP will start new programme and a new country 5 year work plan targeting NGOs and CBOs
- There was 100,000 dollars to be spend within one year as from June 04 to June 05
- UNDP is supporting Forest Action Network to address issues affecting forests in Kenya
- Other projects supported by the UNDP are

- The one administered by ESDA a project on Energy Policy Development,
- Medium size project instituted by ICIPE
- One million dollars targeting private sectors
- Small size project targeting schools
- A project on dry-land targeting FD and IFAWE
- Ministry of Environment and Natural Resources-FD funded by UNDP to carry out an inventory of indigenous vegetation
- UNDP reported there were other projects that have phase out and others coming up

Comments/issues

 NLC members asked the UNDP to circulate the complete matrix of the projects to all members and NK concepts to be included in the matrix

ELCI

Peter Simi reported

- With the formation of the Kenya Organic Agriculture Network (KOAN) a local network that constitutes of large & small scale farmers, Organic standard certifiers, sustainable agriculture training institutes, NGO's, and companies/traders
- Are in the process of formulating organic standards in harmony with standards recognized by the international certifying bodies such as AFRISAT, ECOSAT, IMO
- Creating marketing linkage between farmers and consumers
- Training of District Environment Committee members and legal officers on EMCA through video training aids in Narok & Isiolo
- Formation of an African Civil Society Network on water to engage more effectively with AMCOW (African Ministerial Council on Water) and the UN – CSD processes (the membership was still open)
- It was reported that Eco Forum magazine has been re launched as IKO! Which covers a broader dimension based on Environmental, socio-economic and cultural issues and NLC members were requested to send their articles to be included in the magazine
- On the Water and Sanitation Bill Stakeholders, it was reported that NGO Council has formed a consolidated working group to co-ordinate the process and to submit report to ELCI

Min. of Lands

Tereshia Munyua

 Reported that the physical planning department is putting up an Urban Physical Development Plan and NLC members were requested to give their views towards this process

Comments/issues

- National Land Use Policy (NLUP) is expected to be ready by June 05
- Some NLC members who are NLUP stakeholders have not been invited to attend the meetings that have been held to discuss on the formulation of new land policy. Example is NK who was nominated but have not been invited for the meetings.
- NK asked if she can still participate in NLUP forum
- Teresiha said there was a regional workshop in the week that came after the NLC meeting and most of the NLC members who are stakeholders were expecting to be invited officially.
- There was a concern that Kenya Land Alliance (Civil society) is drawing up a parallel land use policy to that coordinated by the ministry and therefore NLC requested KLA to team up with the ministry

- NLC was informed that the initial arrangement was participatory enough but the civil society felt that their views are not represented.
- CDTF-BCP funded the communities to develop Fourteen Falls site in Thika but there
 has been a controversial over the ownership of the land where the falls is located and the
 Ministry of Land was requested to take action otherwise the community is going to loose
 10 million Kenya shillings meant for that project.
- The NLC was informed that the Director of Physical Planning was doing the assessment in the site

ACC

Jim Nyamu reported

- ACC Mission is to 'Link science, conservation and people'
- Goal is to conserve biodiversity and enhance its values
- Land- use study and land cover changes using satellite imagery in Kajiado, Amboseli, Magadi, South Rift and some parts of Narok District.
- Initiative to create South Rift Tourism Circuit, which links Amboseli to Maasai Mara through Magadi and South Rift. Formation of task force is in the process and a Land trust consisting of landowners to take the process forward, has been formed
- Game Scout ecological Monitoring has been intensified i.e. Amboseli has received a new grant of 6.132.000 from BCP to strengthen Game Scout Ecological monitoring. Game scout network has also been introduced in South Rift Magadi, Olkramatian and Shompole.
- ACC is strengthening the governance of the Natural Resources i.e. building the capacity
 of local community based conservation. By training the Project Implementation
 Committees PIC and community committee members
- Carrying out survey on livestock marketing and changes in seasons, drought. VSF
 (Veterinarians without Border) training of Para- veterinarians to improve livestock health
 in Magadi Shompole and Olkramatian.
- Carrying out a study on elephant population (conserving elephant in Kenya and Tanzania border), identifying the critical areas for elephant and biodiversity conservation and tourism. This is being done with support from Liz Clairborne Art Oltenberg (LCAOF)
- Several conservation areas have been established, Shompole 10,000ha, Olkramatian 10,000ha (both in Magadi), Siana 30,000ha, in Maasai Mara. Through this program benefits to the community through tourisms revenue will be enhanced.
- 1. Clarification: Are there any site support groups in, Amboseli, Magadi or Mara?
- 2. How can ACC integrate its goal with these site support groups?

KFWG

Enock Kanyanya reported

- Got an endorsement letter from NEMA and JICA to carry an EIA for the construction of Northern by pass
- They carried aerial survey of Mau complex forest which was sponsored by BCP and UNEP and the findings were presented to Ministry of Environment and Natural Resources and the Ministry of Lands
- Forest Bill 2005, Alliance was formed to look unto the bill and there is a support by MPs, Regional endorsement, and respectful people in Kenya.
- KFWG inconjugation Charles Nyindiga presented a status report on the Forest blocks that had been aerially surveyed to the Kenya Government and EAC forest sector in the region.
- There were copies of Participatory Forest Management (PFM) Guidelines available during the NLC meeting for members to look them.

IUCN

Laurent Ntahuga reported

• He said East Africa region office have four thematic areas

- i. Water and Wetlands programme focusing on the activities in L.Victoria (Kenya side)
- ii. Marine and Coastal ecosystem programme
- iii. Tree dominant landscapes and Poverty alleviation and Environment; this an area where they will be working more with the local communities
- iv. Species and Biodiversity programme focusing on;
 - Multilateral Environmental Agreements
 - Biosafety and Bio-technology
 - Access in Benefit sharing
 - Africa Convection still to be adopted
 - Ecosystem approach (Indigenous Knowledge)
- IUCN is a lead agency in Mt. Elgon Ecosytem Programme

Nature Kenya

Anthony Kiragu reported

Comments/issues

- It was suggested that NK to enhance collaboration at the site and the donors
- USAID funds projects at Arabuko-Sokoke forest through NK, also NK involves in a commercial project with ICIPE (Insect programme).
- NLC members were informed that Arabuko-Sokoke Management team controls what is
 happening in the forest whereas NK is the facilitator i.e. availing funds to the government and
 CBOs.
- BCP is a co-financer on the projects that is being carried out by NK in Arabuko-Sokoke forest
- Members suggested that a mechanism should be developed on how to execute the projects at the site especially where different donors are funding the same project in one area

Annex 1

Activity Program of the IUCN Eastern Africa Regional Office (EARO) in Nairobi

The IUCN/EARO is part of the global system of the IUCN-World Conservation Union that has its Headquarters in Gland (Switzerland) and pursues the mission of influencing, encouraging and assisting societies throughout the world to conserve the integrity and diversity of nature and ensuring that any use of natural resources is equitable and ecologically sustainable".

The Technical Programme of the EARO is based on 4 thematic areas led by 4 Program Technical Coordinators:

- <u>Water and Wetlands Programme section</u>; headed by Dr Kelly West: current activities are concentrated on river basin conservation (Rufiji, Pangani in TZ) and Lake Victoria basin (Kenyan Side) with an important Nile Perch project.
- <u>Marine and Coastal Ecosystems Programme section</u>: headed by Dr Melita Samoilys: current activities concern marine biodiversity assessments in coastal areas in Tanga and Mnazi (TZ) but will soon embrace also the Red Sea.
- <u>Biodiversity and Species Programme section</u>: headed by Dr Laurent Ntahuga, current activities are centered around the Multilateral Environment Agreements (MEAs) with a main focus on CBD implementation and intend mainly to develop capacity for biodiversity conservation in the region.
- <u>Tree-dominated landscapes and poverty alleviation Programme section:</u> headed by Edmund Barrow, current activities are focused on livelihoods and conservation as well as on forest and dry-land conservation in Kenya
