1. Outline progress over the last 6 months (April – September) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up).

Please note this Project commenced on 1 September 2004, and the initial baseline timetable was set back 5 months.

Following fieldwork in the Falkland Islands in January – March 2005, the thousands of specimens collected have been sorted and considerable progress made in determining their taxonomies. This process continues, concentrating on the most specious group, the Diptera (flies).

Two peer-reviewed papers are in preparation. These detail the molecular taxonomy of Falkland Island Coleoptera (beetles) and the morphometric taxonomy of terrestrial lumbricid annelids (worms). A start has been on a paper describing the morphometic taxonomy of Falklands beetles. Papers were presented at meetings of the British Ecological Society and the Royal Entomological Society.

A Plan setting out a long term monitoring programme for invertebrate conservation in the Falkland Islands was produced in May. This has now been agreed after wide consultation.

The Falkland Islands Invertebrates Advisory Group has been expanded to include additional expertise. In addition, interest stimulated by this Project has resulted in a number of new collaborations with work being carried out on spiders, Lepdioptera and freshwater branchiopod crustaceans.

Two project newsletters (Invertebrata Falklandica) have been produced (April and July). These, along with previous newsletters, are now available to view online. Work is continuing to develop materials for the major invertebrates section on the new Falklands Conservation website.

The Schools Invertebrates Pack has been sent out for review to Falkland schools (primary, junior and Community) and is currently being assessed by our Education Officer as part of a wider Community and Citizen Science Programme. As part of this educational initiative, a butterfly recorder calendar has been designed for distribution to farmers and landowners. It is expected that this will not only aid in publicising the project and Darwin Initiative, but also generate valuable information on the flight times and distribution of Falkland Island butterflies.
