Stakeholders, experts meet to review plan

...as mountain chicken depletion continues

Major stakeholders and regional amphibian experts met at the Holy Redeemer Retreat House this week to discuss plans which would protect the mountain chicken or crapaud, against the threat of chytridiomycosis, which is caused by the chytrid fungus.

This is the second of two regional workshops funded in part under the Darwin Initiative of the United Kingdom Government, as part of a project, "Addressing a Threat to Caribbean Amphibians: Capacity Building in Dominica",

The first was held in Dominica in March 2006 and was designed to raise awareness among wildlife personnel from the Caribbean on the region's amphibian fauna and the chytrid disease, and to begin discussion on designing a strategic management plan to combat this disease.

The second workshop was intended to review work done over the last two years, and also review the draft of a regional management plan to combat the disease with a view to adoption of the plan. While the project focuses on Dominican amphibians, it also highlights the need for regional action to halt the spread of the disease among the amphibian populations in the region.

Participants were from St. Kitts/Nevis, Montscrrat, Guadeloupe, St. Lucia, St. Vincent & The Grenadines, Trinidad, the US Virgin Islands and the host country Dominica.

Speaking on behalf of the Minister for Agriculture at the opening ceremony of the International Workshop on Prevention of Chytrid Spread and Early Surveillance Measures, Minister for Economic Planning and Urban Renewal Julius



Timothy explained that urgent action is needed to protect one of the country's most prized posses-

"We are very concerned about the occurrence of the chytrid fungus and the presence of the disease among our amphibian population...it has not only destroyed and threatened the survival fortunes of our mountain chicken but has also indicated to us that something strange is occurring in the environment," he noted.

Timothy noted that the mountain chicken plays significant role in the balance of nature and their survival is therefore essential to the environment and other creatures.

"...they also assist in keeping down the populations of insects and other pests that may cause damage to agriculrural produce," Timothy also stated.

Timothy explained the severity of the situation has slightly diminished Parks for their dedica-

since the initial outbreak and urged the public to come on board in order to preserve the presence of the crapaud on island.

'It is estimated that between 2003 and 2004, Dominica's population of mountain chicken had declined by some 80%... since then, the government of Dominica has taken steps to safeguard the remaining mountain chicken population from further exploitation and further risk of imported sources of infection," he

"A total and indefinite ban on the hunting of the mountain chicken was imposed and the importation of frogs or frog meat into Dominica has also been banned...between the period of diagnosis of the disease on island and present, many developments have occurred," the Minister added.

He prused the officers at the Division of Forestry, Wildlife and

tion to the prevention of the Crapaud's extinction and their work since the threat was realised over five years ago.

"Once the alarm was sounded about the devastating disease affecting the amphibians, the Forestry and Wildlife Division rose to the challenge and set plans in motion to determine the scale of the problem...the script was written and the stage was set for what we are presently doing," he noted.

With the assistance of the Veterinary Unit of the division of Agriculture, and together with the able assistance of a number of concerned nationals, the field investigations began...samples of dying and dead animals were collected and were even

Chytridiomycosis is an infectious disease that affects amphibians worldwide. It is caused by the Chytrid fungus (Batrachochytrium dendrobatidis), a fungus capable of causing sporadic deaths in some amphibian popula-

tions and 100% mortality in others

The disease has been implicated in the mass die-offs and species extinctions of frogs in the past 15 years, but its origin and its true impact on populations remain uncertain and are under investiga-
