1. Outline progress over the last 6 months (April – September) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up).

There has been little activity at the Antsohihy captive-rearing facility during this period as the birds have been separated into single-sex groups to prevent, temporarily, any further breeding. This was to be expected as it coincides with the driest part of the year and the non-breeding period for the remnant wild population. All 18 birds bred 2011-2012 (11 males and 7 females) have fledged and are thriving. Materials used to construct the aviaries in 2011 have been reviewed and replaced where necessary. A further aviary block was built at the facility. All husbandry protocols have been reviewed and improved as the facility becomes established. Pest-control programmes have been developed as vermin (notably rats) have begun to establish. This was to be expected.

Andy Bamford, Felix Razafindrajao and their team have continued to closely monitor the wild population at Bemanevika and have begun to collect data on potential sites for re-introduction of captive-bred pochards. This process has included visits to each potential site in Sofia and further south in Madagascar to Antananarivo and Lake Itasy. Experts from WWT will visit those sites considered most suitable in November with the team ahead of a three-day planning workshop (with Project and other local NGOs) in Antananarivo.

Jacques Live Rajaonarison (Asity Madagascar) has continued to be based at Bealanana and has worked within village communities and schools around Bealanana and Bemanevika lakes. The Peregrine Fund retain their camp at the Bemanevika lakes and the New Protected Area (Nouvelles Aires Protégés) continues to be supported.

2. Give details of any notable problems or unexpected developments that the project has encountered over the last 6 months. Explain what impact these could have on the project and whether the changes will affect the budget and timetable of project activities.

In order to best support the Antsohihy facility during critical periods (mostly during the breeding season) external avicultural support was reduced following the separation of the pochards into non-breeding groups. In-country personnel would continue to maintain the facility with remote support (through Skype, phonecalls and by internet) and with full in-country support such as the Durrell staff in Antananarivo and full-time veterinary cover (Tsanta Fiderana Rakotonanahary). Unfortunately this temporary change in policy was disturbed in April when facility manager

Floriot Randrianarimangason broke a leg in a motor-cycle accident and was side-lined for three months. The Project was able to send two external technicians at short notice (both had spent several periods at the facility before) for brief periods to help cover the staff shortage. Guardien Rabenalimanana Samuelson (Samuel), who had increasingly become involved in the daily husbandry was moved to become a full-time aviculuralist. Mahazaka Ratsimalandy and Samuel proved very competent and Floriot returned to work at the facility in mid-July. The temporary absence of Floriot undoubtedly slowed the work to establish the breeding centre at Anjingo as communications from Antananarivo (or from outside Madagascar) to the relevant authorities and construction companies in Sofia were difficult. Disappointingly, extraction of further eggs from the wild population will not be possible in 2012 and will be held over until 2013.

Genetic analysis of the founder birds in the captive population has not yet been possible through unexpected damage to two sets of samples exported to the UK. A third set will be collected shortly and stored with a different medium before export. This has not affected the breeding programme as the studbook can be used for most suitable pairings.

A request will be made to transfer money held over from earlier in the project (£39,264) into a Y4 for egg extraction at Bemanevika.
