Outline progress over the last 6 months (April – September) against the agreed baseline timetable for the project

Output 1. Activities for Q1 and Q2:

1.1. Hold inception stakeholder workshop to launch project and assess priorities for academic and field course content

- Two day combined inception and teacher training workshop held 27-28 September 2012. 13 lecturers from the Forestry Training Institute (FTI), University of Liberia (UL) and the Nimba County Community College (NCCC) were introduced to the concept of conservation biology and the module development process. USB flash drives with the training materials, conservation articles and an eBook were presented to each instructor.
- 1.2 Devise and develop 6 academic modules and embed into curriculums of UL and FTI
- MSc student from the University of Cambridge hosted June –July 2012 to conduct a curriculum gap analysis for conservation topics at UL and FTI and review employee's needs. Full report available
- In partnership with lecturers, 12 modules have been created under two courses Biodiversity Conservation I (An Introduction) and Biodiversity II (Species and habitat management) for insertion into curriculums. To date seven modules have been inserted into the FTI curriculum.

Output 2. Activities for Q1 and Q2

2.1. CEERCL Steering Committee formed and operational

- A Memorandum of Understanding (MOU) has been agreed and signed by all partners: FFI, UL, FTI, Forestry Development Authority (FDA) and Zoological Society of London (ZSL).
- Terms of Reference have been drafted for the CEERCL Steering Committee and the first meeting was held on the 22nd of September 2012. A business plan is being developed

2.3 Construct and equip research centre and campsite

- Land was secured for the construction of the research centre in Jalays Town, adjacent to the Sapo National Park (SNP) and the land certificate has been received.
- 3 quotations were received for the constructions and one building contractor was selected.
- Construction of the main office, manager house and campsite commenced on 9th June 2012 with a ground-breaking ceremony. The buildings are still under construction.
- ZSL course modules have been received and will be adapted for the first field course in Jan 2013.

Output 3. Activities for Q1 and Q2

3.1 Conduct an in-depth review of current understanding of SNP's biodiversity and identify knowledge gaps

- Knowledge gap analysis completed and report produced.
- Based on a gap analysis, we have started an internship programme that currently supports 4 UL graduates through i) training on conservation issues, research methods and soft skills such as proposal development and ii) support for research grant application

3.3 Clear and map a trail system in the park for use by researchers, rangers and tourists

• Due to delays in completing the construction of the centre, this activity will now take place in 2013

3.4 Continuation and growth of SNP bio-monitoring programme

 SNP Park biologist and FDA regional extension officer based in SNP participated in the inception / teachers training workshop on Conservation biology

3.5. Host national and international researchers to conduct applied research work

- Researchers from Manchester Metropolitan University, Birdlife, Lund University, Sweden and University College London have expressed interest in conducting research on birds, primates, insects and human ecology. In all cases training for Liberian students will be incorporated.
