PROJECT IMPLEMENTATION TIMETABLE

a) Outline progress over the last six months against the agreed baseline timetable for the project. If some milestones have not been achieved or have slipped, explain reasons for this.

Progress:

- Ongoing training in biodiversity assessment and marine environmental training progressing well
- Initially, six personnel were indicated for SCUBA-dive training in June 1999. This number has now been extended to 18-36 personnel as training has been requested in each of Seychelles, Mauritius and Rodrigues, although training will be later in the year than anticipated (see below)

Delays:

- Main SCUBA-diving training not yet completed: However, PADI / BSAC diving instructor (Mr John Nortcliffe) due to travel to Seychelles and Mauritius on 17 November 1999.
- Severe delays in clearance of equipment through customs in Mauritius resulted in less progress than anticipated. However, freight has now cleared (early October 1999), and is being utilised immediately
- Main casualty of these delays was production of the marine educational poster(s). This has been discussed with the Darwin Initiative secretariat, and explained that our Shoals artist (Miss Charlotte Johnstone) is currently overseas visiting all the field bases and providing content and design for the poster. We hope that the first poster will be distributed in January 2000, the second before the end of the first quarter 2000
- b) What progress has the project made in achieving its objectives over the last six months? Is the project still expected to achieve all the original objectives which were specified? Explain any problems/difficulties which have been encountered to date in achieving the objectives of the project (or any which you envisage may be encountered in the future).

The project expected to more than achieve its original objectives in the overall timetable of the funding, but some of the timing has slipped in this period. Progress is outlined below:

- Marine biodiversity training offered by Drs Helge Vogt, Graham Oliver, Bill Burnett and Mr Iain Watt including marine benthos sampling, preservation techniques and biodiversity assessment.
- Practical reef survey training given by Dr Helge Vogt in coral reef survey methodology (using REEFCHECK and manta-tow) in Rodrigues with members of the Rodrigues Underwater Group (RUG)
- Extensive medical and first aid training provided in Rodrigues and Seychelles by Dr Bev Holt in Seychelles and Rodrigues: workshops given in Marine hazards, drowning, diving, snorkelling and envenomation, followed by practical sessions on boat rescue, oxygen administration and care of casualties in small boats. Total number of attendees c. 70
- c) What lessons can be learnt from your experiences (both good and bad) over the last six months?

- Importing large amounts of equipment into a country, even with a rigorous Memorandum of Understanding in place with the host nation government, can incur serious delays. Ideally, commitments should not be made to start projects until clearance of equipment has taken place.
- The significant delays resulting from these governmental procedures have been costly both in terms of lost time and financial liability, including storage fees, and requiring hire of equipment, boats and vehicles.
- Identification of most relevant and requested local issue to be covered in initial poster takes considerable time, including time for local networking and integration of project. A commitment to produce such educational materials in the first year was therefore ambitious.
