1. Outline progress over the last 6 months (April – September) against the agreed baseline timetable for the project (if your project has started less than 6 months ago, please report on the period since start up).

Completed work during this period followed the timetable set-out in the last annual report. Bat conservation surveys were conducted at two sites in western Madagascar in April and July and at the eastern Zahamena-Ankeniheny rainforest corridor. Microchiropterans were radio-tracked at two sites in a study on forest dependency. Flying fox research and monitoring continued in the east where local partners participate in radio tracking bats at threatened roosts. Short studies were also conducted of seed dispersal and pollination by fruit bats in western Madagascar, A Darwin Assistant graduated with his DEA (MSc) and another conducted a 1-month study visit to Henry Doorly Zoo (US). Workshops were held in two locations to develop a pilot project for integrating bat conservation messages into primary schools. Madagasikara Voakajy's board of trustees (Conseil d'Administration) met in June. Additional funding levered: Disney Wildlife Foundation (\$21k), Conservation International (\$31k), Bat Conservation International (\$2.5k), AZA Conservation Endowment Fund (\$19k)
