4. Summary of proposed Fellowship (no more than 100 words) ie Purpose and expected outputs and outcome

The aim of the Fellowship is to strengthen the leadership potential of a mid-career technical staff member of a BirdLife Partner organisation (Guyra Paraguay) by enhancing her knowledge and understanding of policy analyses and advocacy with a special focus on the CBD process. This will lead to active participation of the BirdLife Partner in CBD implementation in Paraguay and thus substantially enhance the capacity for CBD implementation in the country. The Darwin Fellowship candidate who has very recently been re-designated as a Policy Officer has previously worked as a scientist for Guyra with limited exposure to the policy process.

6. Describe briefly the aims, activities and achievements of the UK Host organisation. (Large institutions please note that this should describe your unit or department) (150 words)

BirdLife International Partnership is a global network of autonomous national membership based NGOs actively working in 107 countries for the sustainable use and management of the world's natural resources. The Partners work together on shared policies and programs of conservation action and policy advocacy while exchanging skills and information across the network. The Partnership is supported by a Secretariat (the applicant herein). Activities of the Secretariat include scientific research and advocacy of conservation priorities. It also supports capacity building across the Partnership to increase required capabilities and skills. BirdLife actively demonstrates the value of biodiversity in providing ecosystem services and interconnections between the needs of poorest people and sustaining biological diversity. The Partnership brings skills and capacity to conservation and sustainable development in a democratic, participatory and transparent way. BirdLife creates collaborative relationships with the international community, with Governments, the private sector and a full range of civil society.

7. Describe briefly the aims, activities and achievements of the proposed Darwin Fellow's employing organisation. (Large institutions please note that this should describe your unit or department) (150 words)

Guyra Paraguay is widely acclaimed for its role in biodiversity conservation in Paraguay and Latin America more generally. It is one of the most active and committed partners of Birdlife International in the Americas. Its mission is to protect and defend the biodiversity of Paraguay working in concert with indigenous and local communities. Its activities include research in areas important for biodiversity, publishing environmental information as well as supporting the Government through the provision of information and management expertise. Guyra has published about 100 biodiversity related books and has identified 57 Important Bird Areas (IBAs). Guyra also owns land for conservation purpose. It has recently created three Local Conservations Groups in IBAs in Paraguay that are implementing biological monitoring and other conservation related activities. The principal approach of Guyra is to work with the central and local governments, and to implement all activities with the support of local communities.

8. Describe briefly the proposed Fellow's current role within their organisation and their link to a Darwin project, including the project reference number, his/her role in that project and any ongoing involvement. (200 words)

Up until February this year, Nilda Maria Leticia Lopez Sosa was a Conservation Officer at Guyra Paraguay. She was in charge of implementing wildlife conservation projects and training local communities. She had close and on-going contact with local governments providing advice and expertise in environment matters. She also developed funding proposals for projects with a principal focus on the Millennium Development Goals (especially MDG7 on environmental sustainability) with local governments. Of recent, she has been coordinating a project helping to implement the Ramsar Convention and CBD in Paraguay. Her role in the project is to gather biodiversity-related information for inclusion in CBD national reports and to undertake scoping studies on ways to implement effectively the CBD national action plan in Paraguay. Her performance in these tasks, amongst others, has led to her re-designation as a Policy Officer within the organisation with effect from February 2010. Her new role will involve working more actively with the implementation of the Convention on Biological Diversity (CBD). In her previous role, she has provided scientific information that is currently being used in the implementation of an on-going Darwin Initiative post-project in Paraguay. The project's reference is EIDPO029.

The aim of the Fellowship is to strengthen the leadership potential of a mid-career technical staff member of a BirdLife Partner organisation (Guyra Paraguay) by enhancing her knowledge and understanding of policy analyses and advocacy with a special focus on the CBD process. This will lead to active participation of the BirdLife Partner in CBD implementation in Paraguay and thus substantially enhance the capacity for CBD implementation in the country. Guyra Paraguay is a strong and leading conservation organisation that is highly acclaimed internationally.

Weak institutional and individual capacity is a major obstacle to implementing the Convention on Biological Diversity in countries that are rich in biodiversity but poor in financial resources. One way in which CBD Authorities could address this is to ensure the active participation of all stakeholders especially by involving national NGOs and other groups. However, the majority of staff, particularly middle-level technical staff, in conservation NGOs such as those in the BirdLife International Partnership holds scientific qualifications and/or background but with little or no training in other aspects of NGO leadership such as policy. They are unfamiliar with the CBD and the ways in which to contribute in its implementation. It is therefore important to work to increase staff knowledge and skills so that they become familiar with the Convention and increase their confidence and ability to contribute effectively. This will both enhance the leadership potential of individual staff and also contribute significantly to the development of the Partner organisations that employ them whilst helping to increase capacity in their respective countries. Further, the participation of people with a strong scientific background will help to foster stronger science-policy links in the national CBD process.

The Darwin Fellowship candidate is Nilda Maria **Leticia Lopez** Sosa (Female, 28 years), a Paraguayan citizen employed by Guyra Paraguay as a Conservation Officer who has recently been deployed as a Policy Officer. She has worked mainly as a scientist for Guyra with limited exposure to the policy process. To achieve its objectives, it is hoped that at the end of the Fellowship the Darwin Fellow will have;

- Gained a deep understanding of the Convention on Biological Diversity and its national processes,
- Obtained and applied basic skills in policy analyses and advocacy,
- Produced a technical report and ancillary advocacy products highlighting the status and trends of Paraguay's avian biodiversity,
- Received international exposure and an increased understanding of the workings of the CBD and BirdLife International Partnership,
- Developed a network of relevant contacts in the UK and internationally.

The approach to be followed for the Fellowship is that of learning through experience; that is, learning by doing, observing and reflecting. During the period; the officer, who has qualifications and background in science but limited experience in policy advocacy, will be involved in research projects and other tasks, consistent with her own individual interests, that will increase her knowledge, skills and expertise in these areas. She will work with staff members from the Science, Policy & Information Management Department at the BirdLife Secretariat who are involved with BirdLife's engagement with the CBD. She will be supervised by Dr Muhtari Aminu-Kano, Senior Adviser- Policy & Advocacy. He leads the team responsible for facilitating and supporting the Partnership's policy analyses and advocacy work with Multilateral Environment Agreements (MEAs). His function includes facilitating communications across the Partnership to develop positions on priority policy issues, helping to raise resources for policy advocacy and helping to develop capacity by managing policy and advocacy projects. He is also BirdLife International's focal point on the Convention on Biological Diversity.

In particular she will collate, compile and analyse information held by Guyra Paraguay and other Paraguayan entities as well as data from BirdLife's comprehensive World Bird's Data Base to produce case studies that illustrate the state of Paraguay's birds, the threats facing them and the policy responses being undertaken. These case studies will then be used to produce a policy document that presents an 'Outlook for Paraguay's Birds'. Initially, readings and web study will be assigned in the early stages of the Fellowship. Secondly the Fellow will be assisted to design and conduct her research through individual supervision as she moves through the project. Thirdly she will be closely involved in BirdLife's preparation for the CBD's 10th Conference of the Parties and be a part of the BirdLife delegation at the meeting as a way of gaining hands-on experience. Fourthly arrangements will be made for her to visit other Cambridge-based conservation organisations such as the UNEP-World Conservation Monitoring Centre (WCMC), Fauna & Flora International (FFI) and Traffic. Finally she will be supported to develop a personal follow-up plan for implementation on her return to Paraguay and make a presentation on this to staff of the BirdLife Secretariat.

10. Legacy. Provide information on how the Darwin Fellow will utilise, promote and disseminate the benefits of the Fellowship on return to his/her home country. Will a strategy be developed during the Fellowship to ensure this is achieved? (200 words)

Towards the end of the Fellow's stay in the UK, she will develop a simple personal plan that will include a 6-month's workplan of what she plans to do to promote and disseminate the benefits of the Fellowship on return to her home country. That plan shall include a presentation to staff of her employer as well as how she hopes to establish and maintain contacts with the CBD Authorities in Paraguay. In addition she will develop a strategy to keep and reinforce the contacts with other sectoral government agencies that are important for CBD implementation such as the Ministries of Agriculture and the Foreign Affairs. It shall also include an initial exploration of the ways in which her organisation can contribute more effectively to CBD implementation in Paraguay.

11. How will the Fellowship assist the Fellow's organisation and/or local communities and/or home country in working towards the objectives (or implementation) of the CBD/CITES/CMS? Please refer to specific Articles or cross cutting themes as appropriate. (200 words)

At the final stage of the internship she will develop a personal plan where, based on the experience acquired at the Birdlife International Secretariat, she will include specific programs aimed at supporting local and central governments. She will resume in her new position as Policy and Advocacy Officer at Guyra Paraguay where she will be supporting not only governments but also key stakeholders in the Paraguayan biodiversity community such as municipalities, private industry and local communities.

12. What collaboration has there been with the Darwin Fellow to date in developing the proposal, and what collaboration is planned for the duration of the Fellowship? Where relevant, describe any consultation or collaboration by the proposed Fellow within his/her own country. (200 words)

When the idea of applying for a Darwin Fellowship was mooted at Guyra Paraguay, the candidate participated in an organisation-wide consultation that was held to identify the most suitable candidate. Having made her case that she will be the most appropriate candidate from the organisation to benefit from such an opportunity, she led in drafting the concept of the Fellowship and initiating contacts with the UK host institution. Further, she has been closely involved in developing and finalising the current proposal.

If the proposal is approved by the Darwin Initiative, she plans to discuss its details with other stakeholders in CBD implementation in the country and get their final input and buy-in on the specific research project/s she will undertake in the UK and tailor the final outcome in such a way that will maximise their usefulness to the Paraguayan situation upon her return.

13. Where will the Darwin Fellow be based? Please be specific with organisational details and dates (where more than one location). (200 words)

The Darwin Fellow will be based at the BirdLife International Secretariat in Cambridge, UK. After completing the necessary visa and immigration formalities, the Fellow will travel from Paraguay to the UK where she will be given a desk and necessary Information Technology (IT) and logistic facilities to function at the BirdLife Secretariat.
